

GENERAL TERMS & CONDITIONS OF SALE METALWORKING & WOODWORKING EQUIPMENT & FURNISHINGS FROM KNOXVLLE ESTATE

Buyer's Premium:

A 25% buyer's premium will be added to the high bid. Example: For each \$1,000 bid, a 25% buyer's premium of \$250 will be added to arrive at the total purchase price of \$1,250.

Payment Terms:

Payment must be made in US Dollars and is due **THURSDAY**, **SEPTEMBER 12 BY 12 NOON (ET)**. Once an item has been sold, it becomes the sole responsibility of the Purchaser. No items can be removed until a complete settlement has been made. The PAID receipt ticket will be required in order to remove items from the site. All checks should be made payable to Furrow Auction Company. "ALL SALES ARE FINAL"

Accepted Payment Methods:

Wire Transfer, Company or Personal Check when accompanied by a Bank Letter of Guaranty, Cash or Cashier's Check. Mastercard and Visa will have a 3% surcharge.

Items will be sold in numerical order on Bidspotter.com.

Sales Tax:

No Sales Tax will be collected.

Claims:

No Claims will be allowed after the removal of goods from the premises.

Registration:

By registering as a Bidder and/or participating as a Bidder at the auction sale Bidder is bound by the Terms & Conditions set forth. Bidder agrees that such Terms & Conditions are binding on the Bidder. Bidder agrees that Auctioneer is in control of the conduct of the auction sale and has the right to reject any bid by any Bidder at the auction sale.
