



## **GENERAL TERMS & CONDITIONS OF SALE**

### **Online Only Absolute Auction:**

### **Kietek Roller Mat Conveyor System, Shipping & Sorting equipment**

**Starts to Close: November 21 @10am**

#### **Buyer's Premium:**

A 25% buyer's premium will be added to the high bid. Example: For each \$1,000 bid, a 25% buyer's premium of \$250 will be added to arrive at the total purchase price of \$1,250.

#### **Payment Terms:**

Payment must be made in US Dollars and **must be made by Friday, November 22, 4pm (ET)**. Once an item has been sold, it becomes the sole responsibility of the Purchaser. Items will be sold in numerical order.

#### **Sales Tax:**

No sales tax will be collected.

#### **Claims:**

No Claims will be allowed after the removal of goods from the premises.

#### **Registration:**

By registering as a Bidder and/or participating as a Bidder in the auction sale, Bidder is bound by the Terms & Conditions set forth.
