

GENERAL TERMS & CONDITIONS OF SALE

ONLINE ONLY ABSOLUTE AUCTION: WOODSTREAM HARDWOODS INVENTORY Bidding starts to close: April 23 @ 10am

Buyer's Premium:

A 25% buyer's premium will be added to the high bid. Example: For each \$1,000 bid, a 25% buyer's premium of \$250 will be added to arrive at the total purchase price of \$1,250.

Payment Terms:

Payment must be made in US Dollars and **must be made by Thursday, April 10 4pm (ET)**. Once an item has been sold, it becomes the sole responsibility of the Purchaser. No items can be removed until a complete settlement has been made. The PAID receipt ticket will be required in order to remove items from the site. Accepted Payment Methods:

Sales Tax:

Claims:

Registration:
